KITIKMEOT INUIT ASSOCIATION APPLICATION FOR RECORD SUSPENSION (PARDON)

What is a Record Suspension?

A Record Suspension (formerly a Pardon) allows people convicted of a criminal offence to have their criminal record kept separate and apart from other criminal records.

The Parole Board of Canada (PBC) grants (and denies) Record Suspensions.

Why get a Record Suspension?

A criminal record can hold you back from getting a job, or travel.

If you are a KIA beneficiary, you may be eligible for free help with your application. For assistance, please complete this form and deliver it to the KIA.

Are you eligible?

You must have completed your sentence (including Probation) five years ago or more.

If you were sentenced to a Fine, and you did not pay it, you will not get a Record Suspension. Pay it now and wait five years, then apply.

If you have had recent trouble with police, your application may be questioned or denied.

It takes a long time!

It can take three years, or even more, to get a record suspension! Start now.
